AMENDMENT

Rule 35, Chapter 8, Part-D, High Court Rules & Orders, Volume-II is substituted with the following:
 "35. **Remittance of excess amount:** whenever during a month the sum in hand of the Nazir at the District Headquarter or Naib Nazir at the Sub-Divisional/Tehsil Headquarter exceeds Rs.50000/- and Rs.40000/-, respectively, the excess amount shall be deposited in an account to be opened for this particular purpose with the MCB Bank or, in case, no branch of MCB Bank is present in the court vicinity, in the Habib Bank limited."
