- 4. No Age Relaxation shall be permissible to anyone on any ground whatsoever.

- 12. Qualifying/pass marks in the Test and Interview shall be determined by the Authority. The Authority reserves the right to grant relaxation in experience for a particular post keeping in view worth of the organization.
