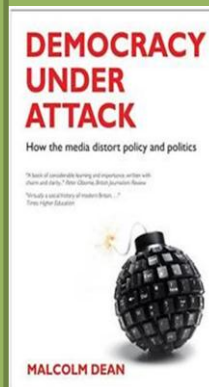
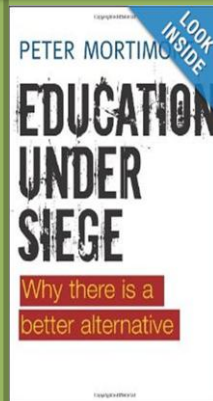
## LIST OF BOOKS FOR THE MONTH OF NOVEMBER, 2013

### EDUCATION UNDER SIEGE PETER MORTIMORE POLICY PRESS, 2013 (ONE COPY)

At a time when education is considered crucial to a country's economic success, recent UK governments have insisted their reforms are the only way to make England's system world class. Yet pupils are tested rather than educated, teachers bullied rather than trusted and parents cast as winners or losers in a gamble for school places. *Education under siege* considers the English education system as it is and as it might be. In a highly accessible style, Peter Mortimore, an author with wide experience of the education sector, both in the UK and abroad, identifies the current system's strengths and weaknesses. He concludes that England has some of the best teachers in the world but one of the most muddled systems.

### DEMOCRACY UNDER ATTACK MALCOLM DEAN POLICY PRESS, 2013 (ONE COPY)

Malcolm Dean, *The Guardian* newspaper's longstanding chief monitor of social affairs, expertly indicts his own trade through a series of seven case studies on the influence of media on social policy. Drawing on four decades of top-level Whitehall briefings, topped up by interviews with 150 policy-makers, the book is packed with insights, and colorful stories from events in Whitehall's corridors, culminating in a damning list detailing the seven deadly sins of the 'reptiles' (modern journalists). A new final chapter reports on the News International hacking scandal, and the subsequent Leveson Inquiry, prompting criminal and civil lawsuits and leading to a radical press regulator plan. Written in an engaging way, it offers a unique insider's perspective Parliament.

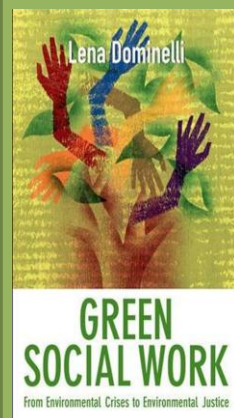
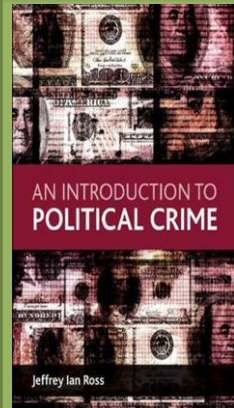


### AN INTRODUCTION TO POLITICAL CRIME JEFFREY IAN ROSS POLICY PRESS, 2012 (ONE COPY)

In *"An Introduction to Political Crime"*, Jeffrey Ian Ross provides the most comprehensive and contemporary analysis of political crime addressing both violent and nonviolent crimes committed by and against the state (e.g. political corruption, illegal domestic surveillance, and human rights violations) in the United States, Canada, United Kingdom and other advanced industrialized democracies since the 1960s. Written by a respected social scientist, and with a companion website containing multiple choice, short answer, and essay questions, this book reviews appropriate theories of political crime and explains numerous definitional and conceptual issues, causes of political crimes, ways to control it, and effects of different types of political crime.

### GREEN SOCIAL WORK LENA DOMINELLI POLITY PRESS, 2012 (ONE COPY)

Social work is the profession that claims to intervene to enhance people's well-being. However, social workers have played a low-key role in environmental issues that increasingly impact on people's well-being, both locally and globally. This compelling new contribution confronts this topic head-on, examining environmental issues from a social work perspective. Lena Dominelli draws attention to the important voice of practitioners working on the ground in the aftermath of environmental disasters, whether these are caused by climate change, industrial accidents or human conflict. The author explores the concept of 'green social work' and its role in using environmental crises to address poverty marginalized populations at local levels.



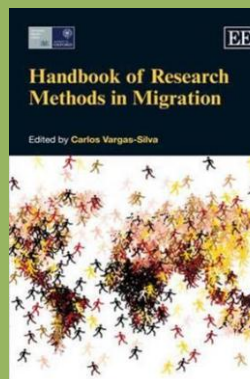
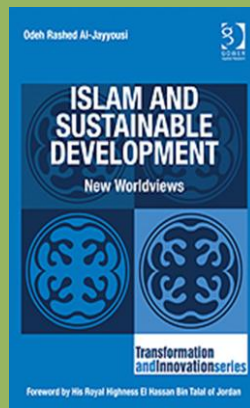
## ISLAM AND SUSTAINABLE DEVELOPMENT
